



# Title 126 – Reporting Requirements

# **State Reporting Requirements**

- Title 126, Chapter 18
- Covers releases of oil or hazardous substances

# **Immediate Notification Required**

- Interpreted at the Federal Level to be within the first 15 minutes.
- Interpreted by NDEQ be within the first 15 minutes.
